(i) Super Veteran's Day - A new date has been selected. A flyer will be sent to all Club Secretaries. Rough copy available for delegates today.

- (iii) AGM is on 18 May. Nomination Forms for Division positions are in the envelope handed to delegates today.
- (iv) Stratford delegate Saturday Pennant Round 13 was cancelled by the Competition Committee due to the hazardous air quality and expected high temperatures. Whilst this was understandable taking into account a duty of care, did the committee have the power to cancel the round under our present rules?
- (v) Loch Sport the new green at Loch Sport has been installed. The Handover from manufacturers (Berry Bowling Surfaces) was held last week. This has seen a big improvement in the conditions at the club. We also expect the green to improve further once it has settled down.
- (vi) Heyfield synthetic green. The Heyfield Club was not happy with the state of some sections of the synthetic green. Tiger Turf will be returning on March 11 to lift the entire carpet. Once this has been done the surface underneath will be repaired, levelled and new bonding material added. Further levels to be taken prior to the return of the carpet.

MIDWEEK PENNANT COMPETITIONS COMMITTEE REPORT 24TH FEBRUARY 2020

All the State and Division events have been completed with the exception of the Midweek Pennant final. Beginning with the division events.

Gail McKenzie starred in a few events by winning the Ch of Ch Singles, then teamed up with Marilyn Steele to win the pairs for the 2nd consecutive year. In the fours final, Kaye Thompson was the skip of the winning team of Marilyn Steele, Rhonda cook and Gail McKenzie.

STATE EVENTS - The singles attracted 8 entries and won by Jan Morton.

- State pairs had 11 entries, up by 4 from last year. This was won by Jan Morton & Gail McKenzie.
- Entries for the State four were very disappointing with only 4 teams from Sale entered. This event was scheduled for Yarram but there was a request that the event be transferred to Sale for this reason. It was washed out on the scheduled first day and all rounds then played on the Friday. Winning team was Jan Morton, Marg Sceney, Pam Carter and Gail McKenzie.

REGION EVENTS – held on 2nd and 9th February at the Bairnsdale B.C.

- Jan Morton and Gail McKenzie won the State Pairs, Gail won the 60+ singles and Jan, Marg, Pam and Gail were winners in the State Fours. All will go on to play in the State finals in Bendigo from 17th April. Julie Simic from Sale defeated Bairnsdale in the Novice singles and will go to Mulgrave on March 1st for the last 16 round, then to Bendigo if successful. Other players/teams who reached the Region finals can be proud of their achievement.

PENNANT -

Section One – In the semi final, top of the ladder, Sale White won against Heyfield so straight to the grand final.

Maffra and Stratford Allstars had moved up to 3rd and 4th on the ladder. With this game, Maffra defeated Stratford.

The Preliminary between Maffra and Heyfield was a tightly contested game with Maffra winning by just 3 shots. The final will now be contested by Sale White and Maffra.

Section Two – In the semi-final, Heyfield Kangas defeated Yarram. Maffra & Sale Blue played off with Sale Blue winning to set up the Preliminary game between Yarram and Sale Blue. Sale blue won this so will now play Heyfield Kangas in the Grand Final.

Both sections will now play the Grand Final at Heyfield on Tuesday 25th (tomorrow).

The weather situation caused some issues on two occasions, with January 14th being cancelled due to hazardous air quality and then some games were washed out on 21st Jan. A potential problem we faced, was that it looked like the first two finals games were going to be threatened by inclement weather so plans had to be in place for the Reserve Day, however, the host Clubs were not available on the listed Reserve Day. Although this didn't happen and may not happen in the future, it needs to be addressed at the beginning of the next season. We wish all players very good and enjoyable bowling in the finals.
